# **Main Purpose**

- Teach and support the learning of children aged 2-5 years in line with the EYFS statutory framework.
- Co-ordinate the provision for children with special educational needs and disabilities (SEND), ensuring early identification, intervention, and inclusive practice.
- Work in partnership with families, staff, and external professionals to secure positive outcomes for all children.
- Promote a safe, engaging, and stimulating learning environment for all pupils.

## **Key Responsibilities**

## **Teaching and Learning**

- Plan and deliver age-appropriate, inclusive learning activities aligned with the EYFS curriculum.
- Use formative assessment to identify children's needs, track progress, and adapt teaching.
- Promote high-quality interactions and early language development.
- Foster independence, curiosity, and a love of learning through continuous provision and playbased pedagogy.
- Apply appropriate teaching strategies for children with SEND, EAL, or additional needs.

#### **SENCo Responsibilities**

- Lead on identification and assessment of SEND needs, ensuring early intervention and use of the graduated approach.
- Maintain the SEND register and provision map; monitor and evaluate interventions.
- Liaise with families, the local authority, and external services (e.g. SALT, EP, Health Visitors) to support individual plans and referrals, including EHCPs.
- Support colleagues in inclusive teaching, adapting provision, and implementing ISP targets.
- Coordinate transition planning for children moving to Reception or other settings.

## Leadership and Collaboration

- Model excellent EYFS practice and inclusive approaches to staff.
- Lead team meetings and support the development of Early Years Practitioners and Teaching Assistants.
- Participate in staff CPD and deliver SEND-related training.
- Contribute to the setting's self-evaluation and improvement planning.

- Safeguard children's wellbeing in line with KCSIE and setting policies.
- Administration and Compliance
- Complete SEND paperwork accurately and in a timely manner.
- Monitor and report on the impact of SEND provision to SLT.
- Ensure compliance with the SEND Code of Practice (2015) and Equality Act (2010).
- Collaborate with DSL to ensure the safeguarding of vulnerable children.

#### **Other Duties**

- Contribute to the wider life of the nursery.
- Take part in staff meetings, training, planning and review cycles.
- Carry out any other reasonable tasks or duties as directed by the Headteacher or Deputy Headteacher, commensurate with the post.
