



Admissions Policy

Lea Nursery School is a community nursery school.

Admission to Lea Nursery School does not mean the child will automatically get a place in any of the neighbouring schools.

THE LOCAL AUTHORITY CO-ORDINATES ADMISSIONS FOR RECEPTION CLASSES.

PARENTS WILL NEED TO APPLY FOR PRIMARY SCHOOL PLACES THROUGH THE SLOUGH BOROUGH COUNCIL WEBSITE.

This policy is applicable to all regardless of gender, sexuality, religious belief or none, culture, ethnicity, ability or disability, individuals with protected characteristics and those with none; it does not determine to discriminate against any individual whilst ensuring the smooth operation of our school.

1. Aims

This policy aims to:

- Explain **how to apply** for a place at the school
- Set out the school's **arrangements for allocating places to the pupils** who apply
- Explain **how to appeal** against a decision not to offer your child a place

2. Places available

The following places are available at Lea Nursery:

- 3–4-year-olds: The Nursery has **65** children in each session (am) and (pm). (**130** part time places.) A maximum of **22** full time equivalent places will be allocated to children who qualify for 30 hours of Nursery Education. There are a limited number of flexible places available- the offer of these places will be dependent on the days required by parents.
- 2–3-year-olds: The Nursery has **10** children in each session (am) and (pm). (**20** - part time places.) We do not offer full time places for 2-year-olds.

Lea Nursery School is open term time only. The term dates are available on our website.

3. Applying for a place

Application forms are available:

- At Lea Nursery School reception
- On the Lea Nursery School website.

Preference for the following categories of children may be specified on the application form:

- Morning (8.35 a.m. to 11.35 a.m.)
- Afternoon (12.20 p.m. to 3.20 p.m.)
- Flexible hours (Two full days 8:00a.m. to 3:20p.m.)
- 30-hour places (8.35a.m. to 2:35p.m. or 8.00a.m. 2:00p.m.)

Parents are asked to indicate if they would like a place for their child as a 2-year-old, or a 3-year-old. Completed application forms should be signed and dated and returned to Lea Nursery School Reception. Visits are available on request. Please **pre-book** these via our Lea Nursery School Reception 01753 536492.

4. Admission Criteria

Places will be offered according to the following criteria:

- (1) Children with educational, medical or social needs. (Applications on these grounds will have to be supported in writing by the relevant professional involved, such as the Special Educational Needs Team, General Practitioner or Social Worker.)
- (2) Children with a brother or sister at Lea Nursery School when the child is due to be admitted.
- (3) Admission is offered on the basis of when the application form is received. (I.e. Children who have been on the waiting list longer will be allocated a place first.)

Places can only be offered to children residing in other Local Education Authorities once children residing in Slough have been offered a place.

Two year old place

Children become eligible for a place the term after they turn 2. From April 2024 the two-year-old provision funding will include:

- Income Support
- income-based Jobseeker's Allowance (JSA)
- income-related Employment and Support Allowance (ESA)
- Universal Credit, and your household income is £15,400 a year or less after tax, not including benefit payments
- the guaranteed element of Pension Credit
- Child Tax Credit, Working Tax Credit (or both), and your household income is £16,190 a year or less before tax
- the Working Tax Credit 4-week run on (the payment you get when you stop qualifying for Working Tax Credit)
- are looked after by a local authority
- have an education, health and care (EHC) plan
- get [Disability Living Allowance](#)
- have left care under an adoption order, special guardianship order or a child arrangements order

Parent in work can apply for 15 hours of funded childcare a week from 1 April 2024 - this is often called 'free hours'. If you're in a couple you both need to be working.

Parents can usually get 15 hours of funded childcare if both the following apply:

If a child is 2 years old or will turn 2 years old before 1 April 2024

parents earn at least £8,670 a year and less than £100,000 a year adjusted net income, which is your income after some tax reliefs and deductions

If you're a couple, you'll both need to earn between these amounts.

If you already get 15 funded hours of childcare from the government you can't get these hours as well.

You can get the 15 hours of funded childcare at the same time as using Tax-Free Childcare or Universal Credit for childcare.

Children who are eligible for a funded entitlement for 2-year-olds place will be allocated places first. (This needs to be applied for online via Slough Borough Council and a code needs to be provided with the application.) If places continue to be available then those parents who do not qualify for the free entitlement will be considered, however there is a payment for these places.

For a free entitlement place for a 2-year-old:

- Applications can be made the term before a child turns 2 for possible admission the term following the child's second birthday.
- Evidence of entitlement to a funded 15-hour place for 2-year-olds will need to be provided.
- On receipt, each application form is stamped and filed in chronological order. Admission is offered on the basis of the date the application form is received and using the admission criteria listed above.
- Lea Nursery School admits children each term if there are vacant places.

- Parents will be asked to show their child's birth certificate and provide their National Insurance Number.
- Unsuccessful applicants will be considered with the next batch of applicants.

For parents who do not qualify for the free entitlement, there is an option to pay for a place if space is available.

- The contract and fees for such places are outlined in the 'Charging and Remission Policy'.
- Children will need to attend for a minimum of 12 hours (3 days) per week.

Children who have a 2-year-old place transfer automatically into the nursery class in or around the term that they turn 3.

Three year old place

Children are eligible for a place the term after they turn 3.

For a place for 3–4-year-olds:

- Applications can be made at any time for possible admission the term following the child's third birthday. It is important to let the nursery know if you move house. The nursery posts out offer letters and you will not receive one unless we have the correct address.
- On receipt, each application form is stamped and filed in chronological order. Admission is offered on the basis of the date the application form is received and using the admission criteria listed above.
- Lea Nursery School admits children each term if there are vacant places.
- Parents will be asked to show their child's birth certificate and provide their National Insurance Number.
- Unsuccessful applicants will be considered with the next batch of applicants.

30 hour place

Some children may be eligible to a thirty-hour place at nursery. There is a maximum of 22, thirty hour places available. The eligibility criteria are available on the Slough Borough Council website. It is advisable to let the nursery know as soon as possible if your child is eligible. An eligibility code will need to be provided.

The admission criteria above apply to 30-hour places.

5. The Process

Parents will be notified either by letter or telephone when a place becomes available. This is generally during the preceding term, although sometimes places become available at short notice.

Parents will be requested to confirm acceptance of the place. Parents are strongly advised to respond within the specified time otherwise the place will automatically be offered to the next child on the waiting list.

Children may be invited to a pre-nursery visit.

It is the school's policy to offer every family an induction session with their Keyworker. At this session we will notify parents of their child's start date and agree with parents a settling in plan based on their child's individual needs.

It is the school's policy to arrange a home visit where this is believed to be in the best interest of the child. The Keyworker and one other adult will visit. The purpose of the visit is to see the child in their home context where

they feel most confident and comfortable. The home visit can help children and the family to develop a relationship with their Keyworker. Parents will be notified of their child's start date at the home visit.

Induction meetings and settling in plans are carried out in a staggered manner. This is so that Keyworkers can take the time to get to know individual children. This helps children to settle in quickly. All children will have carried out a settling in process to ensure they are ready to start at Lea Nursery School at the start of their first term.

If a child leaves during term time, his/her place is allocated immediately to the next child on the waiting list.

6. How to appeal if your child is not offered a place

If your child's application for a place at the nursery is unsuccessful, you will be informed why admission was refused. If you wish to appeal, you must set out the grounds for your appeal in writing and send it to the following address:

7. Monitoring arrangements

This policy will be reviewed and approved by the Governing Body every year.
