




The average attendance % of pupil premium children is 73 % this shows a 9% improvement since 2020 – 2021. The overall 2021 – 2022 cohort attendance figure for 2021 – 2022 is 73% showing the Pupil Premium children are displaying similar attendance to non-Pupil Premium children.


Attainment and Progress of Pupil Premium Children in the 2021-2022 cohort.




These range from 1 to 6 (6 is the level children are hoped to achieve by the time they finish the Early Years Foundation Stage (End of their Reception School Year).































Communication Language, Listening/Attention PP Baseline

Overview of date

Our pupil premium cohort numbers for 2021 – 2022 were average for Lea Nursery. The previous year there was a higher-than-average proportion of pupil premium children (21 pupils). This year a larger percentage of our PP children started at 3 years of age, the previous year, the average age of PP children starting at Lea Nursery was 2 years of age. It is considered that this change has been an impact of COVID and parents delaying sending their children into nursery settings. It is noted that those children who have been with us since 2 years of age achieved secure at expectation attainment levels with some achieving emerging into range 6 in some areas. This is in line with non-Pupil Premium children who also started in our 2-year-old provision. Our work with Pupil Premium children and the overall consistent delivery of the EYFS curriculum this year has shown that all children in Lea Nursery are given equal opportunity to reach their individual potential no matter their economic background or specific needs.

Moving into 2022 – 2023 we are excited about the increased provision and opportunities planned for Pupil Premium children. It should be noted that all children at Lea Nursery are seen as individuals with individual needs and personal circumstances and therefore we bespoke our support and opportunities according. Every child matters and deserves to be given the opportunities to reach their full potential.

Objectives at the end of 2020 – 2021 were to improve attendance, literacy and numeracy progress. Attendance has improved by 9%. Due to the changes to the EYFS September 2021 while this report focusses on the Prime Curriculum areas our data showed that the majority of our Pupil Premium children achieved securely in literacy and numeracy between rangers 4 and 5.

The Pupil Premium children curriculum progress review

We have noted that this year the majority of children have struggled **with Personal Social and Emotional areas** of the curriculum and this has been considered to be an impact of prolonged isolation at home due to COVID 19 during early developmental stages. There has been less wider family and community interactions due to lock downs and some families being advised they are at a higher risk of complications from COVID 19. For infants and toddlers this has had a significant impact on their development in this area. However, we have ensured in our planning and delivery that opportunities and learning experiences have been provided and we are pleased with the progress all pupils made in this area, especially our Pupil Premium children. 70% of pupils achieved securely in range 4 to 5 (age expectations for 3- & 4-year-olds).

Please do note that while some children were noted to be working at emerging in range 6 in some curriculum areas, we have taken the decision to report data as secure in range 5. Individual data would show those emerging in range 6 in the specific areas of strength. Pupil Premium children made the most development in areas of communication and language showing a secure understanding and the ability to listen and focus attention. We were pleased with their development in speaking and literacy skills, however, we will be focussing on this area to increase performance for children in 2022 – 2023.

Pupil Premium children performed particularly well across all areas of physical development.

Results have shown that children are performing within/securely at age expectations. Pupil Premium children have grown in confidence from their experiences and knowledge of the wider world around them. With increased staff ratios pupils have been further supported in developing their level of literary and numeracy.	During Autumn 2021 and Summer 2022 schools continued to be impacted by COVID 19 restrictions, guidelines, and staff and pupil sickness. Despite this Lea Nursery have been proud to continue to support our PP children providing them with additional support and resources. Our work this year and the slow return to a more stable and consistent school year have allowed us to plan and grow our pupil premium initiatives.		

N.B Use of Pupil Premium Funding

The early years pupil premium funding is allocated through the budget sheet and is based on estimated numbers. The figure is adjusted each term when actual numbers are determined. As a result of this we only know our final pupil premium income at the end of the summer holidays, this makes it very challenging to plan the spending. Typically, numbers rise term on term, with some children only appearing on the pupil premium list in the final term of the academic year.

COVID-19 continued to disrupt some of the pupil premium spending and the ability to access opportunities outside of the nursery. However, opportunities were identified termly and actioned.

Priorities for Next Academic Year.

- Continue to improve attendance for all pupil premium children.
- Improved Oral Health for all pupil premium children
- Develop parental understanding of the impact of shared reading at home
- Extend learning opportunities in the wider community
